EVENING EVENT

- Available from 6 – 11 p.m. – cleanup complete and guests departed by 11 p.m.
- Full Event Fee required to reserve your date.
- The total cost of event is the Event Fee plus the number of bottles consumed.

Event Fee

Up to 45 guests = \$450 + tax

Up to 75 guests = \$750 + tax

Up to 100 guests = \$1,000 + tax

BRUNCH EVENT

- Available from 10 a.m. – Noon – winery opens to the public at noon.
- Full Event Fee required to reserve your date.
- The total cost of event is the Event Fee plus the number of bottles consumed.

Event Fee

Up to 15 guests = \$250 + tax

Up to 45 guests = \$450 + tax

BARREL ROOM RENTAL

- Available during business hours only: Thursday – Sunday, Noon – 5 p.m.
- Full Hourly Rate required to reserve your date.
- Client can pre-buy wine upon arrival or guests can pay their way.
- Up to 12 guests seated or 30 guests standing in the room.

Event Fee

\$100 per hour + tax

Please carefully review the following information before booking your event.

Zin Valle Provides:

- Use of our outdoor patio and picnic areas and use of our indoor barrel room.
- The wine glasses and necessary staff to pour and serve wine to your guests.
- Use of our sound system, which streams the XM radio station of your choice or a connection to your phone using Bluetooth. Amplified music, including DJs, are prohibited due to local noise ordinances.

You Are Responsible for:

- All catering for your event – Zin Valle does not have a kitchen for preparation of food.
- All non-alcoholic beverages, including sodas and water. Zin Valle can provide these for your event for an additional fee of \$100 with prior notice.
- Rental of any additional tables, chairs, linens, tableware or decorations.
- Clean up during and after the event including returning furniture back to the original location and sweeping and/or mopping any areas that require it. Failure to properly clean will incur an additional \$250 charge.

Additional Information

- Confetti, rose petals and any other small decorative debris are prohibited as they damage the vineyard.
- The winery does not provide insurance for your special event. The host is responsible for providing any necessary insurance.
- The winery is not responsible for any losses, claims or damage resulting from your event. The host agrees to indemnify, hold harmless and release the winery and its owners, agents, and employees from any claims or losses incurred as a result of the event or in any way directly or indirectly arising out of the event.
- All events must end, with cleanup finished and guests departed by the designated ending time.
